

## Harbor ETFs Estimated 2024 Year-End Distributions

The table below includes estimated year-end distributions for Harbor ETFs. The estimates in the table below are provided to assist shareholders in year-end tax and investment planning. These estimated distributions are based upon projected results for the remainder of the year. Actual distributions may vary, in some cases materially, from the estimates provided. For example, certain estimates and assumptions have been made about income and the number of shares outstanding to estimate the year-end distributions. Actual income may be higher or lower than the estimated income, which could result in the actual distributions being higher or lower than the estimated distributions. The number of shares outstanding may also fluctuate materially between the date the estimates were made and the ex-dividend date of the distribution. This fluctuation could result in a higher or lower distribution than is included in these estimates.

The final distributions for 2024 will be paid on December 26, 2024. Important year-end distribution dates are as follow:
